# SPECIAL NOTIFICATION FOR PUBLIC DISPLAY FLYING

(continuation)

I certify the following in respect of the aforementioned event at which our club intend to give a model aircraft flight display.

1. I have checked and found that public liability insurance cover is not available from the organisers of the event to cover a model aircraft display.
2. I have personally checked the site and I confirm that it conforms to the current MACI guidelines on flying sites.
3. I have discussed the arrangements for spectator control and I am satisfied that sufficient control will be enforced to keep the site safe and suitable for a model aircraft flight display.
4. I confirm that models will only be flown by fully paid up MACI members who are competent pilots (holders of B cert for radio controlled powered fixed wing aircraft or helicopters) and who have current MACI insurance cover and are in possession of a current MACI membership/insurance card.
5. I confirm that all flying will be done in a safe manner and that flying over spectators will not be part of the planned display. All aircraft and equipment will be inspected by the safety officer before being allowed to fly.
6. I confirm that if, either before or during the event, circumstances change in site conditions or spectator control, causing the site to fail to conform to the MACI guidelines, flying will immediately be stopped and no further flying will take place.

I acknowledge that MACI insurance cover will only apply to the model display subject to the above conditions and I further acknowledge that the club will not claim cover under the MACI insurance policy should any of the above conditions fail to be adhered to.
